IMPORTANT REMINDERS

*Residents are responsible for checking their mailbox daily. Any correspondence from the Housing Authority should be opened and read immediately. All correspondence from the Housing Authority is important and should be treated as such. If you change your mailing address or telephone number, you must inform the front office immediately!

*Residents should only contact Housing Authority employees during the office hours of 7:30 a.m. – 5:30 p.m. Monday thru Thursday. If you have a maintenance emergency, you must call the after hours cell phone number of 1-800-791-9344. Any other emergency, you should call 911.

*Remember, there is "NO SMOKING" within 25 feet of any public housing structure!

IMPORTANT REMINDERS

According to your lease Section 13:b

Resident accepts responsibility for the control of pests, vermin and objectionable odors stemming from unsanitary housekeeping practices. Resident also agrees to keep the leased premises and all other areas assigned to resident for his exclusive use free from litter and debris and in a clean and safe condition at all times. Resident also agrees to cooperate with other residents in keeping their common areas (including parking pads) free of litter and debris and in a clean and safe condition at all times. Fines will be issued and repeated violation of this paragraph constitutes good cause for Management to terminate this lease.

NOTICE - Lease Section 12 (g)

Three tickets for violation of section 12(a) (parking on the grass) of the dwelling lease within a (12) twelve-month period will result in Management terminating the lease.
