IMPORTANT REMINDERS

*Residents are responsible for checking their mailbox daily. Any correspondence from the Housing Authority should be opened and read immediately. All correspondence from the Housing Authority is important and should be treated as such. If you change your mailing address or telephone number, you must inform the front office immediately!

*Residents should only contact Housing Authority employees during the office hours of 7:30 a.m. – 5:30 p.m. Monday thru Thursday. If you have a maintenance emergency, you should call the after hours cell phone number of 1-800-791-9344. Any other emergency, you should call 911.

*Remember, there is <u>"NO SMOKING"</u> within 25 feet of any public housing structure!

TENANT REMINDERS

The collections department of the Flint Area Consolidated Housing Authority would like to remind you of the proper procedure for making payments to our office.

Each month, your rent is due on the 1st day of the month. You may mail your payment to our office at P.O. Box 67, drop it in our drop box or come in to the office on 542 Richardson Street in Montezuma to make your payment. You can also make your payment online at flintareahousingauthority.org.

The last day to pay rent before a late fee is charged is the 10th of every month. If your envelope is not post-marked the 10th, in the drop box by 4:30 p.m. on the 10th, or paid inside our office by 4:30 p.m. on the 10th, a late fee is added. No exceptions. It does not matter what date is on your check or money order, if your payment is not in our office by this date and time, a late fee is added.

The last day to pay before your entire account balance is sent to court is the 15th of each month. If your payment is not in the drop box by 4:30 p.m. on the 15th or paid inside our office by 4:30 p.m. on the 15th, your account will be sent to Magistrate Court on the first Thursday after the 15th at 8:00 a.m. **No Exceptions.** Your entire account balance includes: all unpaid rent, all unpaid late fees, all unpaid maintenance fees, and all unpaid security deposit fund balances. In addition to these charges, court fees are also added to your account. It does not matter what date is on your check or money order, if your payment is not in our office by this date, your account goes to court.

Flint Area Consolidated Housing Authority does not accept personal checks or cash for rent payments. The Housing Authority does, however, accept money orders and official bank checks. If you have a good history of paying by personal check, we will continue to accept your check.

Flint Area Consolidated Housing Authority does not accept partial payments for rent. Your money order or official bank check should be made out for the full amount due. We will return partial payments to you by mail if left in the drop box or mailed to our office.

Section 3 E of your lease states that.....

"Management may terminate this lease if Resident is delinquent in paying rent or other charges two (2) times within a twelve (12) month period."
